## **RELEASE OF LIABILITY WAIVER AND ASSUMPTION OF RISK**

In consideration for the rental of Kitesurfing, windsurfing, wingfoiling and other watersports equipment from and/or using the facilities, ground schooling, instruction, premises and equipment of Watersports Center from Coconut Bay in engaging in the sport of Kitesurfing, windsurfing and other watersports-related activities, ground instruction, water instruction, I hereby understand and agree to this release of liability, waiver of legal rights, assumption of risk and to the terms hereof as follows:

- 1. I acknowledge that Kitesurfing, windsurfing, wingfoiling and other watersports-related activities are action sports and recreational activities involving travel in 3 dimensions and such activity is subject to mishap and even injury when participating in these sports.
- 2. I hereby RELEASE AND DISCHARGE WATERSPORT CENTER (Surf Shack at COCONUT BAY) and their officers, directors, agents, employees, instructors and owners of equipment and the land used for Kitesurfing, windsurfing, wingfoiling and other watersports-related activities (hereinafter collectively referred to as "Released Parties"), from any and all liability, claims, demands or causes of action that I may hereafter have for injuries, disability, death or damages arising out of my participation in Kitesurfing, windsurfing, wingfoiling and other watersports-related activities (AUSED BY THE NEGLIGENCE OF THE RELEASED PARTIES.
- 3. I understand and acknowledge Kitesurfing, windsurfing, wingfoiling and other watersports-related activities have inherited dangers that no amount of care, caution, instruction, or expertise can totally eliminate. I EXPRESSLY AND VOLUNTARILY ASSUME ALL RISK OF DEATH OR PERSONAL INJURY SUSTAINED WHILE PARTICIPATING IN KITESURFING, WINDSURFING, WINGFOILING AND OTHER WATERSPORT-RELATED ACTIVITIES.
- 4. I further agree that I WILL NOT SUE OR MAKE A CLAIM against the released parties for damages or other losses. I further INDEMNIFY AND HOLD THE RELEASED PARTIES HARMLESS from all claims sustained as a result of my participation in Kitesurfing, windsurfing, wingfoiling and other watersports-related activities.
- 5. I also agree to accept judgment and cost, including attorney's fees, incurred in connection with any action brought as a result of my participation in Kitesurfing, windsurfing, wingfoiling and other watersports-related activities.
- 6. I will take full responsibility for and hold harmless Released Parties for any injury that I may suffer or inflict upon others or their property as a result of my engaging in Kitesurfing, windsurfing, wingfoiling and other watersports-related activities.
- 7. I agree that I will operate the said Kitesurfing, windsurfing, wingfoiling and other watersports-related equipment in a reasonable and safe manner so as not to endanger the lives of other persons or the property of any individual.
- 8. I have read and understand the above and acknowledge that the same constitutes a release of liability and a waiver of my legal rights and also acknowledgment of the assumption by me of all risks arising out of my engaging in Kitesurfing, windsurfing, wingfoiling and other watersports-related activities.
- 9. I further represent that this release of liability, waiver of legal rights and assumption of risk shall continue in full force and effect for so long as I engage in Kitesurfing, windsurfing, wingfoiling and other watersports-related activities which are in any way connected to or with the Released Parties.
- 10. I further represent that I am at least 18 years of age or that as the parent or legal guardian I waive and release any and all legal rights that may accrue to me or to my minor child as the result of any injury that my son or daughter (minor) may suffer while engaging in Kitesurfing, windsurfing, wingfoiling and other watersports-related activities.
- 11. I have made the Released Parties aware of any existing medical problems that could arise and further represent I am a competent swimmer able to swim a minimum of 100 meters without any problem.
- 12. I hereby expressly recognize that this release of liability, waiver of legal rights and assumption of risk is a contract pursuant to which I have released any and all claims against Released Parties resulting from my participation in Kitesurfing, windsurfing and other watersports-related activities including any claims by the negligence of the Released Parties.
- 13. I hereby expressly acknowledge the areas shown on the map below and understand where the SAFETY AREA is to practice Kitesurfing, windsurfing, wingfoiling and other watersports-related activities. This area is also identified with waves and reefs on the water.
- 14. I understand and acknowledge the limitations and the possibility of the rescue boat not reaching me outside the SAFETY AREA, so I take full responsibility if I cross over the boundaries of the SAFETY AREA shown in the map mentioned in the number 13. I will be at my own risk and any PERSONAL INJURIES SUSTAINED OR ANY DAMAGES

I ACKNOWLEDGE THAT I HAVE CAREFULLY READ THIS WAIVER AND RELEASE (PAGE 1 & 2) AND FULLY UNDERSTAND THAT IT IS A RELEASE OF LIABILITY. I EXPRESSLY AGREE TO RELEASE AND DISCHARGE COCONUT BAY BEACH RESORT & SPA AND ALL OF IT'S AFFILIATES, MANAGERS, EMPLOYEES, REPRESENTATIVES, STAFF, HEIRS, SUCCESSORS FROM ANY AND ALL CLAIMS OR CAUSES OF ACTION AND I AGREE TO VOLUNTARILY GIVE UP OR WAIVE ANY RIGHT THAT I OTHERWISE HAVE TO BRING A LEGAL ACTION AGAINST COCONUT BAY BEACH RESORT & SPA FOR PERSONAL INJURY OR PROPERTY DAMAGE.

IN THE EVENT THAT I SHOULD REQUIRE MEDICAL CARE OR TREATMENT, I AGREE TO BE FINANCIALLY RESPONSIBLE FOR ANY COSTS INCURRED. IN THE EVENT THAT ANY DAMAGE TO EQUIPMENT OR FACILITIES OCCURED AS A RESULT OF MY WILLFUL ACTIONS OR NEGLECT TO FOLLOW INSTRUCTIONS ABOVE, I ACKNOWLEDGE AND AGREE TO BE HELD LIABLE FOR ANY AND ALL COSTS ASSOCIATED WITH ANY ACTIONS OF NEGLECT OR RECKLESSNESS.
